

#### **Travel Advisory Reminders**

November 4, 2020

\*Reviewed and Updated February 9, 2021

Dear Faculty and Staff Members:

New York State has been issuing travel advisories since June 2020, for people traveling to States with elevated community spread and transmission of COVID-19. The NYS Department of Health (DOH) imposes a period of quarantine for people who visit States where it has been determined that the COVID-19 virus has not been adequately controlled and there is significant evidence of infections.

Effective November 4, 2020, Governor Cuomo updated the NYS travel advisory and quarantine requirements (Executive Order 205.2). This new Executive Order implements a "test out" provision for travelers to States and localities covered by the travel advisory. After years of hard work with many months of active support from members of NYSUT and other unions all over the state, new state Sen. John Mannion finally broke through in Central New York's 50th Senate District.

Sworn in Dec. 16 in Albany, the Democrat has been the longtime president of the West Genesee Teachers Association and a NYSUT political activist.



"It's an honor for me and my family," the science teacher said, "but it's a victory for working people in Central New York who will finally have a senator who can bring our voice and our values to Albany." Mannion is a product of the NYSUT Pipeline Project that helps identify, train and support local union members who are interested in running for office. Highlights from our February 2021 OCTA Meeting

\*There is still concern about the Governor's budget. The state is looking to take back funding. NY State is saying if the Federal Gov't doesn't give funding to the State for schools then the state will need to withhold funding to make the Federal Gov't have to give money to the states. **Keep an eye on things and be sure to participate in the MAC**.

\*OCTA is working on a Families First Corona Response Act MOA. FFCRA expired Jan 1st. This MOA will cover all bargaining units to allow members to use their sick days if there is a need to quarantine.

\*A tutoring MOA is being worked on so teachers will be able to apply for tutoring jobs that could take place during our breaks and still get paid. Currently teachers are not able to take jobs with the district during breaks due to already being during the break.

ENV Insurance Company are folks who are our insurance brokers and act as our liaisons and problem solvers. They are super helpful and local, and can be reached by calling them at 315-641-5848 or 800-641-5848 or emailing <u>callcenter@insurewithenv.com</u>

While it's completely okay to contact Aetna, it might be easier to call ENV with the problem as they are very familiar with our self-funded plan and they chat with Melissa and me almost everyday.

# NYSUT statement on federal government's decision to require state standardized exams

ALBANY, N.Y. Feb. 23, 2021 — New York State United Teachers today strongly rebuked the federal government's decision to mandate that states administer standardized tests this school year.

"In a year that has been anything but standard, mandating that students take standardized tests just doesn't make sense," NYSUT President Andy Pallotta said. "As the


educators in the classroom, we have always known that standardized tests are not the best way to measure a child's development, and they are especially unreliable right now. We need to ensure that our students who have been hit hardest during the pandemic receive the support they need. Sizing up students with inequitable and stressful exams is not the solution."

<u>NYSUT previously encouraged</u> the state to request a federal waiver of grades 3–8 and high school testing requirements. Thousands of comments were submitted to the state by educators demanding a waiver of testing requirements this year.

"We have grave concerns that standardized tests at any level can be administered in any sort of equitable way," NYSUT Executive Vice President Jolene T. DiBrango said. "Students deserve better. Regardless of what flexibility the federal government provides, no student should be forced to come to school in person just to take

a test."


SUBJECT: NYSUT Alert - February 23, 2021 - Update from NYSUT

#### **Executive Order #202.95**

Last night the Governor issued a new Executive Order (EO) number 202.95 regarding teachers and the COVID-19 vaccine. More specifically, the EO requires teachers who receive the COVID-19 vaccination to report the immunization to their school. Beginning February 24, 2021, schools and school district are required to report, on a weekly basis, to the New York State Department of Healthy the number of completed COVID-19 vaccinations reported in the prior week, as well as the number and percentage of teachers instructing students in-person during the prior week. Such weekly report shall include any other data elements as the Commissioner of Health determines to be appropriate to track in-person instruction in such schools and school districts.


