Message from your OCTA President - Carrie Patane

Your union officers value your input and appreciate the contributions you make every day to improve our schools, our district, and our profession. We are grateful for all the responses we received to our recent request for contract proposals, and our negotiations team will be meeting at length to formalize your requests into a package that will be shared with Dr. Kilmer and the district's negotiations team at the end of February. We will also be seeking your input on next year's



instructional calendar. With the state mandate of 180 instructional days, required state testing days, the need to schedule up to 6 snow days, and additional required vacation days (Juneteenth and Lunar New Year), the calendar is tight. Dr. Kilmer has proposed a calendar that would require us to sign a Memorandum of Agreement to authorize the district to schedule our opening day conference before Labor Day. You should have received a survey that was sent to your email address today. Kindly respond to this survey by 4pm Monday, February 5th. Thank you for your insight and wisdom as we navigate the ever-changing landscape of our district's future.

In addition to our local union activism, we all have an obligation to our students and profession to stay involved, informed, and well-versed on the topics and conversations surrounding education on a national level, including the challenges we must overcome on our way to better serving our unique populations and communities.

I hope you have an opportunity to read one or more of the articles from our affiliates' publications including an article in the most recent edition of the <u>NEA Today</u> entitled: <u>Educators Fight Book Bans Through Their Union</u>. You might also browse the recent edition of the <u>NYSUT United Magazine</u> where you will find <u>an article recounting the positive legislative package</u> that will strengthen the rights of SRPs and public sector workers.

Whatever goals and aspirations you have, remember that you are not alone on this evolving journey! It is through relationships and togetherness that we will begin to reap the fruits of our labor. I wish you all a happy and fulfilling new year!

Many retirees wish they began focusing on financial and retirement planning much earlier in their lives. Don't let that happen to you! No matter how far along you are in your career, careful financial and retirement planning are critical. That's why our Pension & Retirement Education Program (PREP) seminar is so valuable.

The PREP seminar will help you understand your NYSTRS benefits while also providing essential retirement-planning tips. This information will help you develop a plan to achieve your retirement goals and dreams.

Topics covered during this half-day seminar include:

- NYSTRS Benefits: Your pension, disability coverage, loans, vesting and death benefits.
- Financial Planning: Saving early, catching up, withdrawals and financial advisors.
- Social Security: Benefits, eligibility rules, when to collect and earning limits.
- Estate Planning: Wills, trusts, powers of attorney, health care proxies and living wills.
- The Retirement Process: Retirement options, "resigning" vs. "retiring," choosing a retirement date, retirement checklist, monthly payments, taxes and earnings limitations on NYS public employment.

Seminars are held from 8:30 a.m. to 1 p.m., with registration beginning at 8 a.m. There is no fee to attend and your spouse/companion is welcome to attend, but you must make a reservation in advance. (Note: These seminars are not designed for individual retirement counseling.)

PREP seminars often fill up, so book early. Can't attend a seminar now? We begin taking reservations for our three PREP schedules during the year in: mid-September (fall schedule); mid-December (winter/spring schedule); and, mid-May (summer schedule).

Dental Benefits Reminder!submitted by OCTA Dental Administrator Lindsay Voigt

Just a friendly reminder from OCTA Dental: Please take note of the Plan language that stipulates enrollees are entitled to two cleanings/preventative visits per 12-month period, and Visit A and Visit C of such visits need to be scheduled a minimum of 12-months and one day from each other—For example, if you went to the provider on June 20, 2023 (Visit A), and your next visit was on December 23, 2023 (Visit B), your next visit would need to be scheduled on June 21,

2023 (Visit C) or later in order to be covered—

Providers always try to do their best to properly schedule and space appointments, but ultimately the responsibility rests on members to ensure that their appointments are properly spaced based upon the Plan language as described above—

It's not too late to preserve American democracy—yet

Let's start with a thought experiment: A candidate for president is asked to reassure voters that he has no plans to abuse his power, break the law or use the government to go after people. The answer is a no-brainer, right? Of course, this isn't a thought experiment; it's the exact question Fox News host Sean Hannity recently posed to Donald Trump, to which Trump replied that he would be a "dictator," but only on "day one." Many in his party shrugged off the statement or dismissed it as a joke. Americans may be desensitized to Trump's words, even when he says he would be a dictator, given the maelstrom of shocking statements he makes. But he has doubled down on this troubling declaration—the latest in a pattern of his authoritarian leanings.


