With the end of the school year fast approaching, some of you might be thinking about retirement. Retirement letters to the district are due no later than 90 days from the date of retirement. The deadline for retirement letters this year has been moved to APRIL 8 (assuming a resignation as of June 30th and a July 1 date of retirement) to allow members to make an informed decision after attending an informational meeting about contract negotiations. Remember, once a retirement is board approved, it cannot be

rescinded, reversed or revoked! <u>Click here to access the retirement checklist that outlines all the tasks and</u> <u>responsibilities of the soon-to-be-retired educator</u>!

Also, future retirees should schedule an appointment with NYSTRS to ensure that everything is in order! A <u>Benefits Consultation</u> is an important part of retirement planning. A NYSTRS representative will discuss benefits and review personalized benefit estimates. Don't wait to schedule an appointment! For those still 5, 10, or 20+ years away from retirement, the OCTA will hold a NYSTRS informational seminar on April 10th at the OCTA office. <u>Click here to read more about it!</u>



OCTA Officer Elections Taking Place In May



Want to get actively involved in the OCTA? Feel like you could make a difference? Get on this year's BALLOT!

Eligible, active OCTA members can run for building president and vice president positions. Per the current OCTA Constitution, *Elections*

will be held as follows: The President, 2nd Vice President, 4th Vice President, and Secretary in even years and the 1st Vice President, 3rd Vice President, and Treasurer in odd years on the third Thursday in May, and the officers will be elected when they have received a simple majority of the votes cast from the general membership by written ballot in that election. In the event that all candidates are unopposed, the secretary may cast one ballot.

Q: Where can I find the OCTA Contract?

We have uploaded the searchable PDF version of the new OCTA contract to the Personnel Shared Drive folder, '<u>Contracts', and then select 'OCTA'</u>. You can click on the Table of Contents to go to that section and then click on the outer edge of a contract page to go back to the TOC. This works best after downloading the document but may work in the browser, depending on the

platform used when viewing. What is a 457 Savings Plan?

This Plan is a voluntary retirement savings plan offered by New York State and your employer, to allow public employees like you to put aside money from each paycheck toward retirement. The Plan can help bridge the gap between what you have in your pension and Social Security, and how much you'll need in retirement. The Plan offers both traditional pre-tax and Roth 457(b) accounts to provide you with retirement savings choices.




